





Dear Alumni, Parents and Benefactors of Wah Yan,

Wah Yan College Kowloon is an aided school with a large campus, whole-school small class teaching, a resulting above-standard staff establishment and a wide range of extra-curricular activities. However, we receive standard rates of government grants as any other aided school, and therefore we need additional funds to subsidize the repairs of aging school buildings, the replacement of old equipment (*see photos below for examples*) and furniture by new ones, and educational activities of students especially those under-financed by Government and other sources.



The 2012/13 school year marks the 60th anniversary of the Waterloo Road campus, and the School is launching a fundraising campaign. Examples of items that will benefit from this exercise include:

Replacement of the all desktop computers of more than 7 years old	1,500,000
Upgrading of hardware of the Hall (including urgently needed toilet improvement and stage amenities)	1,200,000
Relocation and renovation of Music Room and Computer Room	500,000
Recurrent annual expenditure for the next 3 years, including items such as: School-based courses to improve students' thinking skills, interview skills, planning and preparation for further studies, etc.	420,000
International Ignatian students' leadership training jointly organized with other Jesuit schools in Asia-Pacific	240,000
Honoraria for voluntary teachers	330,000
Other repairs and extra-curricular activities (music, sports and other cultural programmes, non-academic awards, etc.) ¹	1,810,000
Total	6,000,000

Ways of Donating

- Naming of room:** Large Staff Room with 2 parts: \$1,000,000 for whole room or \$500,000 for each part; Physics Lab / Geography Room: \$500,000@. (Already named in this campaign: Computer Room, Music Room)
- Stone engraving on the left wall (Wall of Shields) behind the School Chapel** (photo below right): \$30,000@


Design of engraving on a stone (more samples on p.5)



- Naming of a "stone" on a wall *printed* in the next volume of *The Shield*:** \$200@
- Naming of new sitting bench** (lifespan of bench usually exceeds 10 years): metallic name plaque attached to bench that will replace old benches like the one shown on the right; \$20,000@
- Fixed amount monthly contribution** (\$100 or above) or **one-off donation**

As the Society of Jesus has decided that we are not going to join the Direct Subsidy Scheme, your generous contribution will equip our School with the hardware and software necessary in providing high quality Jesuit education without resorting to charging high fees.
